Course Description:

Examines human use of forest resources in America from pre-Colombian times to the present. Exploration of factors that impact the use of wood products.

General Education Foundation (GEF):

Forest and Natural Resources 100 counts under GEF requirement F5. Human Inquiry & the Past – Students will interpret historical events or philosophical perspectives to identify patterns, develop analytical reasoning, apply methods of critical inquiry or expand problem-solving skills.

Course Objectives

The course is intended to develop understanding about the use of forest resources and the factors affecting decisions impacting that use. An historical approach will be employed to illustrate how various scientific, technological, and supply issues affect resource use.

Expected Learning Outcomes:

Upon successful completion of this course, students will be able to:

- 1. Explain the critically important role forests and forest products played in the history and development of the nation. (GEF F5)
- 2. Describe of the breadth of the history of the use and abuse of forest resources in the U.S. from pre-Columbian to modern times. They will also prove critical thinking skills by analyzing how policymakers and ordinary citizens have distinguished between the two during different eras in American history. (GEF F5)

- 3. Assess how societal attitudes toward forest resources have changed over time and how human attitudes and values have led to development of the American conservation movement; growth of the conservation professions (forestry, wildlife management, and wood science); and implementation of government policy to both protect forests and promote use of forest products. (GEF F5)
- 4. Demonstrate reasonable knowledge of how anatomical, chemical, physical, and mechanical properties of various woods native to North America have influenced the wide variety of products that have come from wood. (GEF F5)
- 5. Compare how demand and use of wood-based products has changed over time from a regional to a global perspective and the impact of that use on society and the environment. (GEF F5)
- 6. Summarize the principal applications of wood and wood-based materials including the important positive and negative attributes of the use of those products and those of alternative materials. (GEF F5)
- 7. Recognize the major policy, regulation, environmental and other societal issues that impact the manufacturing and use of wood-based products. (GEF F5)
- 8. Distinguish sound from unsound decisions concerning their personal use of resources and land based upon critical environmental, economic, and societal criteria. (GEF F5)

Assignments (6):

Homework assignments will be accessed in eCampus. Students will need to complete the work and submit their original and individual work in eCampus. Each assignment is worth 25 points.

Discussions (4):

Discussions will be accessed in eCampus.

Discussions will be required for each unit. Your initial post is due the day of the opening unit. During the second day for the given unit, you are required to respond and ask at least one meaningful question of two separate classmate's posts. During the third day for the given unit, you will need to answer all questions posted to your initial post. If for any reason you do not receive any question the second day for the given unit, ask another question to any of your classmates. I would like to see at least 4 posts for each student (per Discussion)

Your initial post for Discussion 1 (D1) is due on DAY 1. Each Discussion is worth 25 points.
